- a. Financial Update Angela O'Brien explained the monthly financial update and answered board members' questions.
 - a. 31aa Funding Student Mental Health 31aa funding and uses of the funding were discussed as a revenue stream.
- b. Board Policies Jerry McComb, Mark Frost, and Kate Alles completed the last batch of board policies. The board was presented with the final batch of policies for approval prior to the meeting.
- c. Open Enrollment for 2024-2025 School Year Angela O'Brien reviewed the enrollment plans for the 2024-2025 school year with the board. The plan outlined open enrollment to run Monday, January 15 Friday, June 7, 2024. The open enrollment notice will be posted in the GR Press two weeks prior to the open enrollment period. At the next board meeting, the board members requested to vote

- upon adding the GR Times and a Spanish newspaper in our policy outlining the open enrollment notification.
- d. Board Vacancy Update Cheryl Edwards-Cannon re-introduced Melisha Roberts. Melisha attended the meeting to observe and again express her interest in joining the board. Melisha was given a chance to ask the board members questions and Cheryl reiterated the new board member onboarding process.
